Dear Sirs, On May 25, 2018, „GDPR“, a new EU regulation that aims to unify data protection regulations across the EU, came into force. We take the utmost care in connection with the processing of personal data, in particular in preventing unauthorized access, loss or unlawful distribution. Your image will also be used to disseminate photos and company materials from our events on the Internet, e-mail, social networking sites. Your personal data will be processed to issue invoices regarding our activities and information about our current offer.
3. . Personal data will be stored until you revoke your consent.
4. . You have the right to request access to your personal data from the controller, the right to rectify delete or restrict processing, the right to withdraw consent at any time and the right to data portability.
5. . You have the right to lodge a complaint to the supervisory authority of the President of the Office for Personal Data Protection.
6. . Providing personal data is voluntary, but necessary to carry out orders in accordance with the contract. In case of failure to provide data it will not be possible to execute the contract.
7. . Data provided by you will not be made available to third parties. Recipients of data will be only institutions authorized by law.
8. . Data made available by you will not be subject to profiling.
9. . Your personal data will be stored and processed for the period necessary for the performance of the contractual obligation. In accordance with Regulation (EU) 2016/679 of the European Parliament and of the Council of 27.04.2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46/EC (hereinafter: GDPR) applicable from 25.05.2018.
